There was a group of people protesting in front of Matsumoto Restaurant on Larchmont Avenue Wednesday night.

What was it all about?

Dear Curious:

People who were in the restaurant at the time tell the Loop there were about 20 people, clearly all High School students. The signs they were carrying indicated they were upset because the owner had failed to hire an African American MHS Senior because of her race. One sign reportedly read, "We can have a black President, why not a black Hostess?"

The owner of the restaurant, who is quite upset by all this, says this is absolutely untrue and race had nothing to do with the fact that she did not get a job there.

owner and asked him if it was possible if I could take the job. He agreed stating that he was very happy to have me on the team and could not wait to meet me. I was to begin that night and begin training as well as getting paid. I arrived at the restaurant and began training with my friend behind the counter. About a half hour later, the owner came in and was very hesitant about shaking my hand or even saying hello. Ten minutes later he pulled my friend aside and she came back to me sobbing to the point that she could not speak. I took her outside to calm her down and that is where she proceeded to tell me that the owner refused to hire me because I was black and that I would drive business away from the restaurant. We then re-entered the store, grabbed our belongings and left.

I was taking the job because I desperately needed, and still need, money in order to attend college this fall and Matsumoto was the first place to offer me a chance to obtain a job.

But we used the protest in order to show the Larchmont community what was happening and that we, as a community, should not let this happen. As my friend said, when she was confronted by the owner, "This isn't like 1940's Birmingham, Alabama - this is a liberal town in the Northeast in 2009"
